The Vienna conference is meant to study in more details the aspect of the reception of various commissions on diversity, with scholars, community leaders and policy makers. The emphasis is to study how to improve media strategies and particularly how to communicate the outcomes of these commissions so as to improve their impact, mostly nationally but with an eye on the processes of cross-fertilization transnationally. It will involve various countries (not only North-Atlantic), through scholars whose research focuses on one or the comparison of these commissions, as well as actual and potential policy makers interested in their implementation. The basic themes are:

- Receptions of commission reports on cultural and religious diversity;
- Promotion of and/or resistance to recommendations by national political parties;
- Challenges and experiences in formulating recommendations for better implementation by policy makers;
- Challenges and success stories of media coverage of commission results and recommendations;
- Role of policy makers in shaping socio-political responses to religious diversity;
- Communication processes and strategies in developing final reports and recommendations;
- Challenges of implementing public policy recommendations, etc.

This conference is based on a collaboration between:
